- Called the meeting to order 7:40p
- Welcomed new members

Mike Ellingson motioned to accept nomination of Rebecca Yoby as Freshman VP; Krystal Spahr seconded.

- Minutes from May 23, 2018 meeting presented on website
- Motion to approve minutes as written by Kim York; Michelle Guinigundo seconded; motion carried.

Finance – Beth Dodson

- Financials presented on website
- Question about the outcome of rookie band jackets – Andy decided to not do rookie jackets; he is looking at other options on how to best use the funds; there will be a subsequent vote before funds are used
- Motion to accept financials as presented by Krystal Spahr; Steve Johnson seconded; motion carried.

Mattress Sale – Steve Johnson

- 11th annual mattress sale Sept 15, 2018
- Kids don't need to sell anything; just do referrals; share event via social media; band makes money
- Incentives for kids (jackets and cash prizes)
- Battle of the bands – competition between the top 10 bands doing mattress sale; \$10 for each mattress sold at top 10 school bands goes into kitty; top band gets kitty at end of contest

Cookie Dough Fundraiser – Jen Daiker

- Raised just under \$9,000; about 40% profit for each sale
- Need 5 volunteers to help sort on Wednesday, August 29 – 3p LWHS band room
- Cookie dough will be distributed to kids on Wednesday, Aug 29 after practice at 530p

- Kids to wear show shirts Saturday morning (if they come in tomorrow – otherwise will wear polo shirt from summer uniform)
