

# Lakota West Upbeat Meeting

### Director's report – Andy Carr

- **Charms** – bands will be posted tonight
- **New Director** – 128 applicants for Tom's job; interviews (5-6 people) will be Monday; will have top 2 candidates conduct band after school (open to any current band kids); will host get together with parents this spring to introduce new director
- **Grad Band** – rehearsals going well – kids not required to come to their band exam time; grad band will go in as their exam grade
- **Symphonic winds** – will turn in their All-State audio recording as their exam grade; will not have to come during their exam time
- **Marching band** –
  - rookie assessment went well; 62 new members
  - looks to be about 210 members based on commitment forms; staff of 10
  - expect new uniforms in mid-July; may need to adjust date for group picture; already have a backup date in place in case the uniforms are delayed;
  - will only fit for summer uniforms and shoes during band camp fitting night
  - Long sleeve red shirt will be used long term; used for football games
  - Show shirt – lighter material; kids will buy and keep each year; unique to each show
- **OMEA Solo and Ensemble** – Andy has requested a change to where we are in the rotation which would move the event away from President's Day weekend; hasn't heard back
- **OMEA District contest** – first weekend of spring break; option to go out of district (Harrison and Troy are other locations) but there's no money to provide buses; parents wouldn't be able to come; would probably not go at all; instead looking at Music for All and large group event at Lakota East (outside of OMEA)
- **Mason Music for All** – we are promised 2 spots; they have clinic format instead of sight reading; winds and symphonic bands would go; trying to get concert bands in as well – if not able to do this – concert bands will go with freshman bands to East event
- **Lakota East/West** - large group event to be held at East – March 6; 2 freshman bands and 2 concert bands; 4 clinicians would come; one group listens; one group warms up; one group performs; one group in clinic time
- **Jazz n Cakes** – March 28, 2020
- **Spring concerts** – March 2 and 3, 2020
- **Marching Band schedule issues** –
  - **BOA show Oct 5** – “Southwest Regional” is now going to be held at Ball State University (2hr 15min) so they offered to move us to a different location (one was on homecoming; one in Columbus; one in Toledo) so we will stay registered at current location; if we draw 8am, will probably drop; if it's a reasonable time, we'll go but it will be more expensive than budgeted
  - **Oct 19** – three possibilities (Centerville; Kettering and Colerain); will go to either one or two of these
  - **Nov 2** – West Clermont competition
  - **State finals** – can only go if we do an OMEA show during the season; shows open for registration on June 1<sup>st</sup>

### **Finance – Beth Dodson**

- Budget presented; motion to approve Kevin Moorman; Deb Pizzuco seconded; motion carried
- Annual budget
  - same categories as last year; numbers put in based on how we did this current year
  - Shed construction – \$3,600.00
  - Website – new hosting company
  - Winds trip chaperones
  - Indy trip chaperones
  - Freshman t-shirts – need to purchase this year – only have a few leftovers
  - Prop budget – difficult for Andy to get supplies; have to order in advance through district
  - Angel fund – already fully funded; money diverted to shed/props
  - Motion to approve budget by Kevin Moorman; Deb Pizzuco seconded; motion carried

- Main event raised \$116.70; low turnout; they said we can do anytime except December and January; need to move it to another time for next year
- Uno's still set for every other month
