a. Upbeat Club Articles of Incorporation \& By-Laws: Revisions to Executive Board Positions- Over time we have grown and evolved. We have a Freshman VP and this was here because originally the Freshman didn't march in addition to be in a separate school and it was a way to help incorporate them. That is not the case anymore, so we think it's time for an update. We would like to rename the Freshman VP position and the regular VP position. The scope of what we do has grown and changed and it seems like a great opportunity to restructure a little bit. ON the website with the agenda are the changes we are looking to make. We have to change our articles or incorporation with the state. The change is simple but will need to be submitted is that article 5.10 position names will change to VP of student experiences, VP of Events, and VP of communications. These new positions will replace the Freshman VP and regular VP and create a new position. VP of student experiences will be in charge of things like band camp, meals, Friday night. VP of events will help oversee all big fundraising events such as the invitational, tag day, Jazz $n$ Cakes, etc. The bylaws will be updated to reflect the changes. The bylaws are not submitted to the state. We looked at the boards at Fairfield, Mason, and East and we had the
smallest board and felt it was reasonable to expand. The bylaws say that a vote requires 4 regardless so no worries about a tie with 6 instead of 5 .
